#### 9. FMBB World Cup and FMBB World Championship 2016/2017/2018.

- 2016
- France:
  - MR. Gilbert Geuvel informed the meeting about the date (9 to 15 May 2016), location (Aubigny Sur Mère) and the sleeping facilities.
  - Sponsor are Royal Canin and Euro Joe.
  - ➤ Website will be available within 10 days (www.fmbb2016.fr)
- **2017**
- Provisional candidature from Germany, this has to be confirmed by the German Club.
- 2018
- Italy:
  - Mr. Egidio Budelli confirms the candidature for Italy.
    This will be followed up by the FMBB secretary in the following months.
- 2019
- Greece:
  - Greece has asked for more detailed information concerning the organization of the World Championships.
  - Greece is also asking the board to help them to resolve the actual problems with the Kennel Club Greece.
    - The board will do the necessary to provide help in this matter.

#### 10. Questions

- Italy: Mr. Egidio Budelli:
  - Question about the way judges are chosen for the coming championships:
    - ➤ Here we refer to the existing implementation rules for the different disciplines.
  - Can we, before the judges are confirmed, ask the opinion of the Belgian Shepherd Club in the country of origin?
    - This question will be treated on the next FMBB Board meeting.
- Finland: Mia Skogster:
  - Would it be possible to add a "curriculum vitae" to the proposals for the judges?
    - This was discussed within the meeting and has been approved, we will add this to the general rules.
- Finland ( Mia Skogster) & Jersey (Jarmilla Pallot)
  - There was no field available for IPO class 3 training.
    - (Dusan) we had an agreement with a local football club to use their field for training. Because of possible theft risk, we were not able to leave the blends, jump and a-frame on this field.
- Finland: Mia Skogster:
  - Would it be possible to designate one person from the local organization per country to be the team's single point of contact to with all questions and help with all possible issues? (like it was in Finland).
    - If this is possible to do by the organizing country, this can be done.
- Sweden:
  - Can we send email to all clubs to ask information about the proposed judges?

- Slovakia:
  - Can all reports from FMBB meetings be made available to the member clubs?

- U.S.A.: Shari Lipski
